



3. OBJECTS:

The Objects of the trust shall be the following:

- (a) To open, run and a School/ Schools or College/ colleges from Nursery to University level for boys and girls in acts in arts, Science, Commerce and other profession or technical causes, vocational causes and/ or useful knowledge to develop knowledge and character of students as well as to educate them in physical culture.
- (b) To establish and a boarding / non- boarding school with house/ hostel for the students of the School run by the trust.
- (c) To organize Seminar, symposium, workshops, Arts & crafts training camps, trade fair etc. for the welfare of the students and parents.
- (d) To give financial assistance such aid, scholarship, stipends, etc. to the poor and meritorious students irrespective of the casts, creed, religion, race sex or place of birth.
- (e) To receive grants, charity, donation, loans etc. from government or non government organizations.
- (f) To conduct other activity or activities or schemes which may deem and understood to be necessary for welfare of students, people as well as society as a whole.
- (g) The educational institutions established and / or run by the trust shall be minority institutions and shall be under the protection of Article 30 of Indian Constitution.

4. STATUS


The trust shall be non-political and charitable organization. The trust created as a charitable public trust shall not be revocable at the instance of the founder of the trust at any time and under any circumstances.

5. POWER TO ACCEPT DONATION AND GRANT IN AID:

The trust may at any time accept donations or loans from India and abroad and also accept grant in aid from the individuals, Govt. or non Govt. agencies or philanthropist people and organizations.

6. DECLARATION OF THE TRUST:

- a) The funds/ income of the trust shall be solely utilized for achieving the objects of the trust and no portion of it shall be utilized for the benefits of the trustees by way of the interest, bonus discounts profit etc.
- b) To pay of it all costs, charges and expenses properly incurred by the trustee in or about the execution of the trust, and
- c) To apply the same in furtherance of the objectives set out above in such a manner as the trustee in their absolute discretion from time to time think fit.





7. TERM OF THE TRUSTEES:

- a) The trustee (who are the executors of this deed) They shall continues as member of committee for whole life shall be empowered to appoint are or more new trustees with same powers, writes status and duty of the executing trustee. In case of death, incapacitation, resignation, removal inability etc. The remaining trustee shall be entitled to nominate any other person as they think fit and proper to act as trustee in the place of the trust so eying or removed or referring to act or unable to act .
- b) The ordinary members may also be added on acceptance of Rs. 500 or more amount with declaration to support the objectives of the trust and their future shall be two years which may be renewed or the next tenure.
- c) Any resolution or question in administration of the trust shall be decided by majority. Quorum of the trust meeting shall be simple majority.

8. TRUSTEE POWER/RIGHTS:


- a) The trustee shall take decision unanimously or by majority to established any institution and also to take any policy decision.
- b) The trustees shall manage the affairs of the trust and institutions, programmes and body/bodies establish by the trustees.
- c) The trustee shall act and performed duties of the fulfillment of the objectives.



- d) Every trustee will have the power to look into the accounts and the accounts books in registers.
- e) Trustee shall be entitled to solicit fund, open and close bank account to event funds in securities etc, to inquiry morable and in movable properties by purchase, lease settlement, gift or by any other mince and to cell or transfer or lease or pledge or otherwise dispose of all or any of the properties of the trust.
- f) To appoint employees and settle the terms of service remuneration and termination.
- g) To run "Oxford Convent School" at Sasaram with separate bank account operated by any two trustee or their authorized representatives with separate office and settles to meet the necessity as the case may be.
- h) To sue or be rued in for and in the name of the trust .
- i) To nominate representatives for any of the aforesaid purpose

9. ADVISORY COUNCIL:

Their shall be and advisory council consisting of at least seven member nominated from journalists, Govt. officers, judicial officers, lawyers, businessman, professors ; women, social workers to advice the board of the trustee and the member shall be nominated by the board of trustees.

The trustee shall caused proper books of accounts to be kept in accordance with the law and get in income and expenditure ordited annually at the end of financial year.


12. MEMBERSHIP:

b) The donating above Rs. 25000 shall be "life member" of the trust on expressing faith in the rules and objective of the trust.

c) If Board of trustees shall be empowered to add any new trustee by a resolution passed by 2/3 majority.

14. POWER AND FUNCTIONS OF PRESIDNET/SECRETARY ETC:

1. President:

- a) President shall call and preside over the meeting and board of the trustees and advisory council.
- b) He shall appoint express of the trust and institution run by it .
- c) In case of dispute his decision shall be final and binding on all.

2. Secretary:

- a) Secretary shall conduct executive functions of the trust.
- b) He shall maintain the bank accounts properly.
- c) He shall keep supervisions over the employees and insure complaints of president orders.

3. Treasures:

- a) Treasurer shall keep details of income and expenditure
- b) He shall insure annual audit of income and expenditure.

OPERATION OF ACCOUNTS:

- b) Apart from the main account of the trust these may be different project accounts and the power to operate such account shall be delegated to the appropriate trustee's authorized representative/authority under the trust may chairman or executive trustee as the case may be.
- c) The income and expenditure of the trust and educational institution established and for run by the trust shall be audited annually by a chartered accountant.

DISOLUTION OF THE TRUST:

In case the event of dissolution or winding up of the trust, assets remaining as on the date of the dissolution shall under no circumstances be distributed among the trustees but the same shall be transferred to another trust whose object or similar to this trust.




